

**CITY OF ILWACO
ORDINANCE NO. 888**

**AN ORDINANCE AMENDING THE 2018 BUDGET OF THE CITY OF
ILWACO, WASHINGTON AS ADOPTED BY ORDINANCE #878 AND
AMENDED BY ORDINANCE #883**

WHEREAS, the City of Ilwaco adopted the 2018 budget in final form by Ordinance #878 on December 12, 2017 and amended it on September 24th, 2018 by Ordinance #883; and

WHEREAS, subsequent thereto it has become necessary for the city to amend said ordinance because of revenues and council approved unbudgeted expenditures of same; and

WHEREAS, the city is desirous of amending its budget pursuant to RCW 35A.33.090.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ILWACO, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The following funds contained in the 2018 Budget are hereby amended as follows:


