**AN ORDINANCE OF THE CITY OF ILWACO, WASHINGTON, ESTABLISHING THE  
PROPERTY TAX RATE FOR THE 2021 BUDGET.**

**WHEREAS**, the City Council of the city of Ilwaco has met and considered its budget for the calendar year 2021; and

**WHEREAS**, the district's actual levy amount from the previous year was \$227,670; and

**WHEREAS**, the population of this district is less than 10,000; and


**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ILWACO,  
WASHINGTON, DOES ORDAIN AS FOLLOWS:**

**Section 1.** An increase in the regular property tax levy is hereby authorized for the levy to be collected in the 2021 tax year. The dollar amount of the increase over the actual levy amount from the previous year shall be \$2,288, which is a percentage increase of 1.00496% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.

**Section 2.** Effective Date. This Ordinance shall take effect and is in full force five (5) days after its passage, approval and publication of an approved summary of the title as provided by law.




